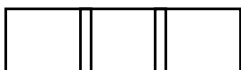


Conditions of Entry- Strip art Show 2018

1. Entrants must be over 16 years of age. Artist may choose to submit up to four works, however hanging will depend on space availability. Late entries will not be accepted.
2. Entry fee is \$5 per work for financial SECAN members and \$8 per work for non members. Entry fee is payable by; Cheque, money order, cash, or direct deposit. BSB: 013479 Account number: 287203664 IMPORTANT: Please enter your full name in the transfer DESCRIPTION field and also advise payment has been made by sending a confirmation email.
3. SIZE: 2 dimensional artworks entered must conform to a strip format with the approximate proportions of 1 to 3, however the actual size of the artwork is up to the artist, being any variation of these proportions. For example: 10cm x 30cm, 30cm x 90cm, up to a maximum size of 60 x180cm. (Commercial stretched canvases should be as close to stipulated proportion and size as possible, some leniency available). Freestanding 3D works are not accepted, however wall hangable 2D work with a sculptural element is encouraged. Orientation of artworks may be vertical or horizontal. 2D works entered that significantly exceed these dimensions will be rejected. Entry fees for oversize artworks will not be refunded.
4. Entries may be framed or unframed but must be submitted with provision for hanging.

6. Work may be in any stable medium and must be the original work of the artist entering.
7. All entries must be clearly labeled indicating, artists name, contact, title, medium and price details.
8. SALES: Works must indicate sale price of work or labeled NFS. There is a 10% commission taken on any sales made. Cheques for all works sold during the exhibition will be posted to the entrant within 30 days of the end of the exhibition. Any cheques issued by us not cashed within 3 months of issue will be cancelled and no correspondence entered into. Requests for 'replacement' cheques will incur \$15 bank fee.
9. SECAN Inc does not collect GST. All prices must be total selling price. Any GST liability between the artist and the ATO remains the responsibility of the artist.
10. ENTRIES CLOSE: Entry forms must be received by the close of business, 5pm Friday 22nd June, 2018. Send completed entry forms and entry fee to: The Treasurer, South Eastern Contemporary Art Network Inc. 9 Bailey Rd, Narre Warren North, VIC, 3804.
11. The selection committee will choose the works for the exhibition from the works received. Please list works entered in order of selection priority as works may not be displayed in the event of overcrowding. SECAN Inc. reserves the right to decline to exhibit any work. Unsafe or wet works will be rejected. Positioning of the artworks will be at the discretion of the curators. The committee's decision is final and no correspondence will be entered into. Any artwork not hung will be refunded.
12. SECAN Inc. will exercise reasonable care with the work submitted, but will not be responsible for any loss or damage whatsoever. Insurance is the responsibility of the artist.
13. DELIVERY: All works to be delivered to the Gate 6 Gallery + Studio, Cardina Street, Akoonah Park, Berwick Wednesday 4th of July 2018, strictly between 3-5pm.
14. Exhibitors agree for their artworks to remain on show for the exhibition duration, early collection will not be permitted. SECAN, at its discretion may allow purchasers to collect works during the exhibition.
15. COLLECTION OF UNSOLD ARTWORKS: Unsold/unselected artworks must be collected between 4pm and 5pm on Sunday the 29th of July 2018.
16. UNCOLLECTED ARTWORKS: Artworks remaining uncollected after the next SECAN meeting date will be removed to storage and will incur a \$10 late collection fee, (per work) payable before works are collected. SECAN Inc. will not be liable for any works remaining uncollected after 14 days, and they will be removed from storage and disposed of as deemed fit and thereafter SECAN shall be under no liability whatever to the artist in respect of any work so destroyed or disposed of.
17. No payment will be made by SECAN Inc. for mail, freight or any other charge incurred in the delivery and or return of any work.
18. SECAN Inc. reserves the right to photograph submitted work for promotion of future exhibitions and archival purposes (printed, electronic and web based.)
